Chairman Narasimhan called the special meeting of the Board of Commissioners to order at 1:06 p.m. on August 10, 2021. All of the Commissioners listed above as present at the meeting were present at that time and remained present throughout the meeting on June 22, 2021, except Commissioner Gibson, who left the meeting as indicated below. Commissioners Artus and Larrazabal participated in the meeting via electronically for medical reasons from their residences in Nelson County and Fairfax County, respectively, as per the Authority’s electronic participation policy. Commissioner Porter participated in the meeting via electronically for a personal matter from 120 Hope Lane in Bristol, as per the Authority’s electronic participation policy.

Chairman Narasimhan, provided an overview of the upcoming annual meeting of the Board of Commissioners on August 29-31, 2022. Chairman Narasimhan also reported on a trend in which tenants in rental properties are not paying rent despite the ability to pay and asked that the staff look at the risk of such behavior might pose to the multi-family loan portfolio.

On motion duly made and seconded, a resolution that the Board convene in closed session to discuss and consider the performance of Ms. Dewey in accordance with Section 2.2-

3711.A.1 of the Code of Virginia and further that Ms. Dewey, Mr. Brennan, Mr. Bryant, Ms. Watson and Ms. Michaels, who are deemed necessary to be present or will reasonably aid the Board of Commissioners in its consideration of the aforesaid topic, be present during the closed session was approved by the affirmative vote of the Commissioners noted above as present at the meeting.
